THE OPPORTUNITY

Andrew Wommack Ministries (AWMI) is a media ministry that broadcasts messages about God's unconditional love and teachings to millions. By providing this tool, not only has AWMI blessed countless individuals in creating a free legal will or trust, but they've also been introduced to a new segment of supporters they'd never talked to before.

AWMI works with a dedicated Faith Partner Success Strategist to ensure that their customized messaging, shared through various channels like television and email, is impactful and reflects their values. As a Christian ministry, they are supported by a Strategist with a ministry background whose insights guarantee all messaging and content is aligned with their core beliefs and resonates authentically with their audience.

Within their first year of partnership, AWMI has achieved an astounding \$109M in legacy gift commitments, invigorating new conversations about the future impact of their ministry.

We're also preparing for future generations, and we believe these gifts will be instrumental in realizing our long-term vision."
